UNDER VIRGINIA LAW, ANY EQUINE ACTIVITY SPONSOR OR EQUINE PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ACTIVITY RESULTING FROM THE INHERENT RISK OF ACTIVITIES. VA. CODE ANN. S-31-796.130(1994)

Equine activities include inherent risks of which you should be aware! They are as follows:

- (A) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine;
- (B) The unpredictability of an equine’s reaction to sounds, sudden movement, unfamiliar objects, persons or other animals;
- (C) Hazards, including, but not limited to, surface or subsurface conditions;
- (D) A collision with another equine, another animal, a person, or an object;
- (E) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an animal or failing to act within the ability of the participant.

My signature below indicates that I am aware of risks involved in exhibiting in this horse show & I voluntarily choose to allow my child(ren) to participate WITHOUT WEARING APPROVED SAFETY HEADGEAR.

I AGREE that I choose to participate voluntarily in the Middlebrook Ruritan Club’s Horse Show, hereafter referred to as “Competition” and I have been made aware of these inherent risks and agree that “show management or their agents” shall not be responsible for any accident or injuries to the horses or persons involved!

I AGREE to release the Competition, The Middlebrook Community Center, The Middlebrook Volunteer Fire Department and the Middlebrook Ruritan Club and any of its members, leaders, families, and officials from all claims for money damages or otherwise for any Harm to me or my horse and for any harm caused by me or my horse to others, even if the Harm resulted directly or indirectly, from the negligence of the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred) the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I AGREE that “Competition” as used above includes all officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I REPRESENT that I am eligible to enter and/or participate under the rules and every horse I am entering is eligible as entered.

If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child’s behalf.

Upon these conditions, I enter the horse listed on the face of this document.
